HEALTH & SAFETY

REGISTRATION DEADLINE

Advance registration ends Friday, October 1, 2021. After that date, you must register onsite at the event.

CANCELLATIONS

All refund/cancellation requests must be received in writing. Cancellations received on or before August 31, 2021 will receive a full refund less \$45 processing fee. Cancellations received September 1-21, 2021 will receive a 50% refund less \$45 processing fee. Cancellations received after September 21, 2021 will not be issued a refund. All refunds will be processed after the event.

SUBSTITUTIONS

Attendee substitutions may be made at any time prior to the event, provided that the substitute is from the same organization.

SUITCASING POLICY

ASTA shall have a zero tolerance policy for suitcasing at the ASTA Annual Meeting or any other ASTA event. Suitcasing is the practice in which companies gain access to an ASTA event, typically by either registering no company employee for the event or registering only one or some company employees for the event, and then such company representatives hold competing events or conduct business with legitimately registered event attendees at the event venue, whether in reserved venue space such as a hotel room or in other public spaces at the event venue. Violators may be subject to the potential penalties as outlined in the ASTA Suitcasing Policy, available at www.astaspice.org.
