



## Trade & Tariff Tracker: Reciprocal Tariff Rates and Negotiation Updates by Country

(As of Dec 18, 2025)

**Background Information:** Reciprocal tariff rates were originally [published](#) by the White House on April 2, with an effective date of April 9, for which a 90-day extension was granted. Then on July 7, the White House published an [Executive Order](#) further extending the reciprocal tariff deadline until August 1, 2025, while a 10% universal tariff rate remained in effect.

Subsequently President Trump indicated intentions to raise the baseline tariff rate and a series of letters were sent to a number of countries outlining increased rates that would be implemented on August 1 if trade deals were not negotiated.

On July 31, modifications to reciprocal tariffs were announced in an [Executive Order](#) published by the White House, outlined in "Annex I". Note: trading partners not listed in Annex I (e.g., Morocco, Egypt) of the Executive Order will be subject to a 10% reciprocal tariff. Most new tariffs went into effect on August 7. In a separate [Executive Order](#) on July 31, President Trump announced the suspension of duty-free *de minimis* tariff exemptions for low-value shipments (<\$800) from all countries.

Table 1 reflects the latest announced reciprocal tariff rates for key spice trading partners and Table 2 includes a comprehensive list of reciprocal rates per Annex I of the July 31 Executive Order or other established deals. Table 3 includes a list of spice tariff codes exempt from reciprocal tariffs per the Malaysia and Cambodia trade deals.

On November 14, a new [Executive Order](#) exempted many spices, alongside other products not grown in the U.S., from reciprocal tariffs globally. Table 4 lists spices that are on "Annex II", and therefore now exempt from reciprocal tariffs. While imports of these spices are now exempt from the *reciprocal tariffs*, other duties, including some IEEPA tariffs remain in place for some countries. A new column has been added to Table 1 breaking out the reciprocal rate (for which Annex II is exempt) and the other IEEPA tariffs (for which Annex II commodities remain subject). Countries for which some IEEPA tariffs remain in effect are highlighted in green. See [ASTA's FAQ's on Reciprocal Tariff Exemptions](#) for more information.
